If <u>all</u> the above answers are NO, you do not need a building permit, but you are responsible to ensure that the tent is at least 3m (10 feet) from any structure or property line, is flame resistant and has clear exits – as specified in subsection 3.14.1 of the Ontario Building Code.

If <u>any</u> of the above answers are YES, a building permit is required according to the Ontario Building Code.

- submit the \$150 inspection fee

\checkmark	Required documentation
	Site plan showing the location of existing structures and the proposed tent locations, including any portable or fixed sanitary facilities.
	A written declaration from the supplier that any fabric or tarpaulin is certified to CAN/ULC S109 or NFPA 701 "Standard for Flame Tests of Flame-Resistant Fabrics and Films."
	If there are internal walls or obstructions in the tent(s), show a floor plan indicating exit routes.
	If the tent is larger than 225m ² (2422 square feet), provide an engineered drawing indicating post and guy wire distribution, or an inspection certificate from a Professional Engineer.
