This addendum is to address the following clarification:

# Clarifications:

The RFP submission deadline remains the same and is not changed by Addendum No. 2.

#### **Questions & Answers:**

- **Q1:** Should a well survey (interview with the well owner to understand the water quality and quantity) on the existing wells be included in the scope of work?
- A1: This is an alternative if the owners do not agree to having their wells taken offline for a day to be sampled.
- **Q2:** Can the Township please confirm the existing wells are with pump and ready to be sampled?
- A2: If the owners agree, the wells are not with pump and ready to be sampled.
- **Q3:** For the Terrain evaluation, is the municipality looking to get conceptual lot designs or actual tested, lot-specific layouts?
- A3: The municipality is not looking for conceptual lot designs. Actual lot specific layouts based on confirmation of soil depth is required for septic system locations.
- **Q4:** Are there surveyed plans detailing the lot layout available for the subdivision? Can these plans be provided in CAD format?
